This terms of use agreement ("Agreement") is effective immediately for all Users of the Website and is by and between you, the User and Grand Rapids Community Foundation ("Foundation" or "we" or "us").

1. Mission

The Foundation is a nonprofit organization that connects people, passion and resources. Our mission is to build and manage our community's permanent endowment and lead the community to strengthen the lives of its people. With our partners, the Foundation uses the tools of philanthropy to find solutions to pressing issues. We provide grants to support the work of nonprofits, scholarships to local students and other forms of support to communities working to eliminate barriers to opportunity, prosperity and belonging. We envision a magnetic and interconnected West Michigan community.

2. User Eligibility

Use of the Website is void where prohibited.
